- c. Field care of game.

Great Plains Outfitters will not be responsible for:

- a. Taxidermy fees incurred by the client.
- b. Bar tabs and/or gratuities to serving staff incurred by the client.
- c. Costs of any miscellaneous activities (i.e. Fishing, bird hunting, etc.)
- d. Processing of meat (\$40.00).

- 3) Final payments must be made the eve before the first hunt day.
- 4) Hunters are expected to have all equipment necessary to hunt. If equipment is needed advance notice would be greatly appreciated.
